This memorandum provides an overview of the 172nd / 190th Corridor Plan project, including the anticipated deliverables and meetings, as well as the roles and responsibilities of project team. This project will combine of technical analysis with public input provided through various forums. The project is scheduled to be completed by January, 2012.

Project Overview

The area around the 172nd/190th Corridor was recently added to the Portland Metropolitan Urban Growth Boundary (part in 1998 and the remainder in 2002) and is planned for urban development at an average density of at least 10 units per net buildable acre for the residential areas. There are also planned commercial and employment areas within the City of Damascus. Some of this development has already begun to occur. As the transportation system exists today, SE 172nd Avenue and SE 190th Drive lack the needed continuity and capacity to serve future traffic demand created by this anticipated urban growth. There are limited locations where this type of connection/facility can occur due to topographic constraints and existing urban buildout. Planning efforts thus far reveal that there are no other physically viable, cost-effective north-south routes in this portion of the county.

The 172nd/190th Corridor Plan program will identify and assess transportation system improvements needed to serve future north-south traffic demand that will come with the buildout of developable land in Happy Valley, Damascus, and Gresham, and to accommodate regional traffic growth.

Overview of Deliverables & Meetings

The project will use a systematic process of preparing and reviewing technical memoranda focused on various elements of the plan. These will serve as the building blocks to prepare the overall corridor plan and implementation strategy. These deliverables will be prepared in coordination with a series of six PAC meetings, four public workshops and a public open house described the preferred plan.

Engagement with these interactions with a wide range of stakeholders will help guide the development of the plan as well as build the necessary consensus and support for acceptance and adoption by the Cities of Damascus and Happy Valley and Clackamas County. The general chronology of activities is summarized in the attached roadmap.

Meeting Schedule

For each meeting, the date and time, key deliverables to be discussed, and the consultant team members who will attend are listed. Project Management Team and Project Advisory Committee members should notify the consultant team of potential conflicts based on the proposed schedule.

Roles & Responsibilities

The project approach has been developed to provide ample opportunities for input from the PAC, PMT, general public, Clackamas County Planning Commission, and Board of County Commissioners. To accomplish all of the tasks before the January 2012 contract end date, adherence to the schedule will be important.

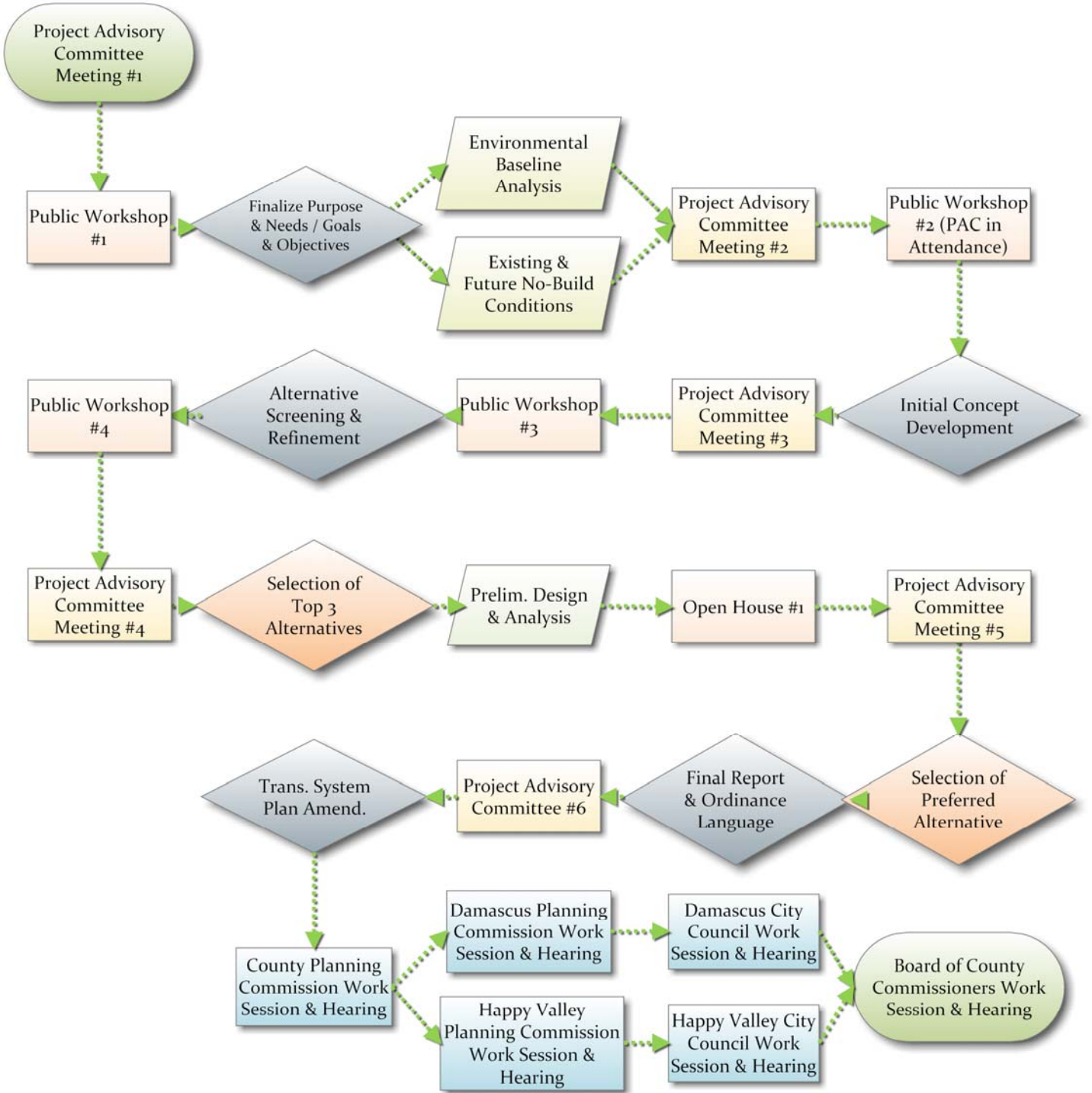
